ITEM 3	CONFIRMATION OF MINUTES The meeting notes of the Committee meeting held 13 th March 2014 are confirmed.	
ITEM 4	Inclusive Playground Ocean Beach Rotary Funding The options and recommendations for the relocation of the Liberty Swing and the concept of 'All Inclusive Play' were discussed at the meeting. The committee agreed that it is not feasible to move the Liberty Swing from Seaforth. But a alternative type swing be investigated for North Steyne. After discussions with Rotary they have nominated that they	

would like to contribute to the project a possible amount of \$40,000

RECOMMENDATION

1. The committee recommend to the General Manager and Council that it is not feasible to move the Liberty swing at Baranbali playground to North Steyne and that a suitable alternative accessible swing be investigated for this location.
2. The committee recommends to the General Manager and Council that the 'All Inclusive Playground' concept proposal presented to the committee from Viva Recreation be accepted as the most appropriate proposal for this location.

The committee discussed the next project to be considered from the 10 year playground strategy. The next most pressing playground to be assessed and reviewed is the Tania Park playground.

RECOMMENDATION
