ITEM 4	MATTERS ARISING Litter The Committee is happy with the continued manual raking of Shelly Beach and would like their appreciation conveyed to Council's Cleansing staff. ITEM 5	GENERAL BUSINESS Workshop Series Several Workshops have been held all of which were well attended. These include: • Compost workshop • Sustainable kitchen • Up cycling workshop for adults • Up cycling workshop for children Nappies The Committee sought information on Council's activities with regard to the use of disposable nappies in child care centres. It was noted that Council had hosted nappy and toilet training workshops and that education material (brochures) were available at Council's child care centres, community health centre and local hospital. The Committee is concerned that Council has not done enough to minimise this type of waste going to landfill. Recommendation: The Committee recommended to the General Manager that: 1. Relivit be invited to attend the next meeting of the Waste Committee to present their business model. Moved: Clr Cathy Griffin Seconded: Clr Candy Bingham Manly Hospital Clr Griffen concerned about the continued littering of cigarette butts and the impact that this has on the local marine environment. Manly Wharf The Committee is concerned with the impacts of smoking in the public areas of the Wharf on human health and the marine environment. Recommendation: The Committee recommended to the General Manager that: 1. Council writes to Manly Wharf Management advising its concern that smoking is likely to occur on the wharf, in particular the outdoor dining areas and seeking clarification from management whether this activity is permitted. It is noted that the public is subjected to smokers in the wharf area and there is concern that this impacts on public health and the environment.
Council requests the installation of signs advising visitors that Manly is smoke free and that smoking is prohibited.
