Manly Youth Strategy

With Council having now adopted the Strategy, actions in the plan can be progressed. It is an opportune time to write to Manly Rotary Sunrise who are looking to fund identified community projects.

Recommendation

1. A letter be sent to Manly Sunrise Rotary Club suggesting that they may wish to consider the Keirle Park skate facility as a local project to fund given it is identified in the Manly Youth Strategy.

Lack of Sexual Health & Women's Health Services in Manly area

A letter from Anthony Dombkins, Director of Nursing & Midwifery, NSLHD dated 22 October 2014 was read, in response to the letter about lack of sexual health & women's health services. It noted the Thursdays-only Beachside Clinic had increased hours due to demand, demand for services is high with resources finite, and NSW sexual health priorities are: gay and homosexually active men, youth, people with HIV, Aboriginal people and sex workers. However, the NSLHD was always reviewing the patterns of STIs, and with the redevelopment of health services on the Northern Beaches, reviews will be ongoing to meet the area's needs. It was suggested that further follow up occur around the issue given there is opportunity for input into the LHD planning processes for the Northern Beaches.

Recommendation

The Committee recommends to the General Manager & Council that:

1. Further contact be made with the NSLHD to advocate for the local needs previously identified.

ITEM 4 PRESENTATION BY MARK D'ASTOLI, FaCS, COMMUNITY SERVICES DIVISION, NORTHERN SYDNEY DISTRICT

Mr D'Astoli, Manager of Sector Development & Planning for FaCS/ Community Services Division, Northern Sydney District, addressed the Committee on: FaCS localisation, the Going Home Staying Home program, Prevention & Early Intervention (PEI) reform, the Youth Framework, and Collective Impact. Points of interest include:

- FaCS has been localised with the Northern Sydney District spanning 11 LGAs – with 3 directorates, 1. Housing, 2. Disability, Home Care & Community Services, and 3. Community & Reform.
- The Going Home Staying Home program – is a more preventative approach to homelessness. Successful tenderers were announced several months ago and covering the NBs are:
 - Generalist East (Mission Australia & Manly Warringah Women's Resource Centre)

- Youth East (Taldumande & Mission Australia)
- Early Intervention (Mission Australia + Ryde FS)
- Service Support Fund (Phoenix and Burdekin)

Some unsuccessful tenderers have been given funding until June 2016 to assist transitioning services eg. Burdekin.

- Prevention & Early Intervention (PEI) program reforms – are a continuum of programs ranging from the broad Community Builders program to statutory Child Protection programs. Reforms are focused on co-design with services and service users, flexibility, sector capacity building, and improved impact measurement, and a new focus is on social return on investment eg. corporate investors, social benefit bonds.
- Collective Impact – Are collaborative projects between services, the community, and the private sector / corporate, and these projects are about joining forces to effect social impact. More common in US where corporate philanthropy is greater, these projects display a common agenda, shared measurement systems, mutually reinforcing activity, continuous communication, and backbone support. Examples of such projects in NSW are the Geelong Project and a similar project, Seaside Strength, which is coming to the NBs. Council's Adolescent Family Counsellors will be involved in aspects of the project along with local schools.

The Committee thanked Mr D'Astoli for his presentation, a copy of which will be distributed to the Committee.

Pioneer Clubhouse:

- Their Community Market Day on 25 October was a success raising \$4,000 and provided community engagement with clients.
- Are involved in the Harbour Bridge Wellness Walk on Sunday 16 November to raise awareness of mental health issues and welcome Committee members to attend.

Manly Club for Seniors:

- Have received funds via Council from SNSB Medicare Local to run falls prevention workshops which run at the Manly Seniors Centre on Fridays from 17 October to 21 November. 60+ enquiries were received after ads were placed in the Manly Daily.
- AGM is on Friday 7 November. Committee members welcome to attend (invitation emailed to Committee on 29 October).

U3A:

- Are interested in using community space under the BUPA aged care facility at the old Seaforth TAFE site.
- Council's Public Domain Committee is providing advice on how this space is best structured.

Manly Community Centre:

- Had a successful AGM on 24 October.
- Are expanding their multicultural services to a branch in Brookvale.
- Have seen increased demand for their Legal Aid clinics.

Subject: Ability Links NSW Program

Introduction

Ability Links NSW (AL NSW) is a new way to support people with disability, their families and carers as part of the ongoing reforms of the disability services system in NSW. It provides people with a locally based first point of contact to support them to access supports and services in their local communities.

Information

Ability Links NSW Coordinators, or "Linkers" as they are known, work with people with disability who are aged 9 to 64 years, their families and carers to help them plan for their future, build on their strengths and skills, and develop networks in their own communities so they can do what they want with their lives - outside of the traditional disability service system.

Linkers also work with local communities to help them become more welcoming and inclusive of people with disability employing community development and universal access principles.

UnitingCare NSW/ACT in partnership with Settlement Services International have been successful in gaining funding to coordinate the program in Northern Sydney, Western Sydney, Nepean Blue Mountains, Illawarra Shoalhaven and Southern NSW Districts. Four "linkers" service the Manly LGA.

This new program is of interest to local service providers including those on the HS&SP Committee.

Recommendation:

- 1. That Barbara Bice, Ability Links NSW Program Coordinator, from Settlement Services International, presents to the Human Services & Social Planning Committee on 24 February 2015, on the AL NSW program. Ms Bice will be accompanied by Local Ability Linkers Anne Springfield and Tania Johnson.**
